### AIM OF JOB:

As a farm hand your role will support with the care of animals, within the farm, during the week.

You will share the drive of the school to provide the highest quality of education, care and preparation for life for all students in the school.

- To be part of a culture of the highest possible standards of care for all animals
- To contribute to raising standards of animal care
- To share and support the school's responsibility to provide and monitor opportunities for personal and academic growth for staff and students

## Responsibilities

As a farm hand, you will need to:

- undertake practical activities involved in the care and welfare of all animals this could include jobs such as driving vehicles, operating machinery, feeding and care of livestock or mending fencing.
- understand the implications of the weather and make contingency plans
- ensure current government regulations concerning farm activities are complied with
- ensure that farm activities comply with government regulations
- monitor animal health and welfare, including liaising with school staff and vets where necessary whilst on duty.
- ensure a clear and accurate hand over of information to weekend staff.
- maintain a knowledge of bio control understanding risk of poor practice
- apply health and safety standards across the farm estate
- protect the environment and maintaining biodiversity
- keep all policy/procedural records up to date.



# **Working hours**

Your working days are Monday to Friday. Additional Weekend cover maybe required and will be paid as overtime should the need arise but must be split between morning and afternoon duties to ensure continuity of routine for our animals.

• Much of the work will be farm based and therefore out in all weathers and seasons.
